Only a limited number of reservations are available and registration is handled strictly on a “first come first served” basis. Completed registration forms received are a preliminary reservation of your place on the tour. No deposit is required to accompany the registration form. A part payment towards the tour in the amount of R14 000.00 per person is due no later than 4 months before the departure date. In the event of the minimum requirement of 25 tour registrations & part payments not been met by the due date, your part payment will be refunded to you. However with a minimum of 25 registrations and part payments received (used to secure flight tickets and other land arrangement reservations) the tour goes ahead and at this point becomes non-refundable. This part payment amount will be deducted from your overall tour price. The balance of the tour price due is to be paid no later than 2 months before the departure date.

Travel Insurance

Tour participants are personally responsible for taking out their own travel and health insurance covering cancellation, loss of baggage, medical expenses, loss of life, injury, hospitalization, curtailment, repatriation, evacuation, repatriation of remains and legal costs. The insurance is to specifically include COVID 19 treatment and hospitalization. Tour participants are responsible for their own quarantine expenses and any required COVID 19 related testing. Travel Time Tours or any persons connected thereto will not be held liable in this regard. Should it become necessary for the tour group either partially or as a whole to quarantine, tour participants is responsible for their own expenses in this regard and Travel Time Tours or any persons connected thereto will not be held liable in this regard or for any disruption, discontinuation or cancellation of the tour program that could result.

Prices / Costing / Payment

The tour price is based on airfare / airport tax and tariffs for land arrangements and hotels at International Rates of Exchange available at the time of composition of the program and is therefore subject to change / alteration in the event of increases in exchange rates until two weeks before the departure date of the tour. The full amount of the tour must be settled by no later than two months prior to the departure date. The tour price is based per person sharing. Without a roommate you are liable for the single supplement fee. Travel Time Tours is not responsible for arranging a roommate.

Cancellation

In the event of a reservation cancellation by a tour applicant / participant: Notice of cancellation must be received in writing at Travel Time Tours (PTY) Ltd (Fax 021 979-0915 or e-mail traveltimetours@outlook.com) two months or more prior to the tour departure date. Any paid fees paid less any expenses, disbursements or commitments already incurred on behalf of the tour applicant / participant will only be refunded if written notification of cancellation is received two months or more in advance of the departure date. No amount will be refunded prior to two months of the departure date.
